Blue Diamond Fashion Stakes Fashion Duo's Category

Terms & Conditions

1. Rules on how to enter form part of the terms and conditions of entry.
2. By submitting your entry form, or registering to participate in the Blue Diamond Fashion Stakes competition, you agree to abide by the competition terms and conditions.
3. All entries in the Fashion Duo's category must consist of two (2) people.
4. Entries can consist of either two (2) males, two (2) females or one (1) male and one (1) female.
5. Entrants can be of any age, but at least one of the entrants in each duo must be 18 years old or older. Entrants under 18 years of age can enter as part of a duo with an adult of 18 years or over, but must have parental consent to enter the Competition.
6. The Promoter is Melbourne Racing Club of Gate 22, Station Street, Caulfield VIC 3162. A.B.N. 96 203 634.
7. Entrants must not be dressed by a fashion designer and failure to comply with this will result in disqualification.
8. Headwear is mandatory for all entrants, both male and female.
9. One heat (Grand Final) will take place on race day. One (1) winning duo and one (1) runner-up duo as determined by the judges, will be chosen from this heat. The Promoter reserves the right to increase or decrease the number of heats, finals, entrants or winners at its complete discretion.
10. Winners will be notified on Saturday, 25th February 2012 (Race Day).
11. There will be one (1) Grand Final Prize winner and one (1) Runner Up only.
12. There will be one (1) prize pack only for the winning Fashion Duo and one (1) prize pack only for the runner up Fashion Duo. These prize packs can be distributed between the winning duo at their own discretion. If one member of the fashion duo winner or runner up is under 18 years of age, alcohol must be given to the member that is over 18 years of age. The Promoter takes no responsibility in ensuring the prize is allocated evenly between the two entrants in the winning Fashion Duo.
13. The runner up duo prize pack will include two (2) MRC Annual Guest Card Memberships for the 2012/2013 Racing Season, two (2) \$100 Noni B vouchers and fashion accessories, two (2) \$100 vouchers from The Cove, two Secret Stylist Salon vouchers plus more.
14. The winning duo prize pack will include an accommodation package for two (2) on Hayman Island,, two (2) MRC Annual Guest Card Memberships for the 2012/2013 Racing Season, two (2) \$150 Noni B vouchers and fashion accessories, a double pass to attend the Young Members' Marquee on The Age Caulfield Guineas Day in October 2012, two (2) tickets to the 2012 AFL Footy Show (excl. 15. Registration will take place from 11.00am – 1.00pm on Race Day unless heats are full before this time or entry is extended by the promoter at their discretion. The registration desk will be located near the main Gate, Gate 23, at Caulfield racecourse. A maximum number of entrants, as determined by the promoter, will be accepted in the competition and once this maximum is reached registration will be closed.
16. Online, faxed or posted pre-registration forms will be accepted until 12pm, Friday, 24th February 2012.

17. All pre-registered entrants must report to the registration desk on race day during the opening times to sign in and confirm their position in one of the heats. Failure to appear during registration opening times will result in their place not being held.
18. Heats may take place any time from 1.00pm on race day.
19. The Blue Diamond Fashion Stakes competition will take place on the Noni B Fashion Stage, located near the front lawn at Caulfield Racecourse. The promoter reserves the right to change the location of the competition on the race day at its complete discretion.
20. Preliminary judging or heats may be introduced at the discretion of the Promoter on Race Day if deemed necessary.
21. The Promoter reserves the right to offer Wild Card entries at any stage throughout Race Day, in which case the entrants will immediately progress to a heat or the grand final (at the Promoter's discretion).
22. All prizes are non-transferable, non-exchangeable and not redeemable for cash. The Promoter reserves the right to substitute an alternative prize at its complete discretion at any point during the Competition.
23. The promoter shall select and appoint the judges.
24. Fashion Duo's will be judged on race wear attire, style, seasonal attention and innovation. Overall presentation, deportment, accessories and coordination of the duo will be considered.
25. The judge's decision is final.
26. The Promoter will determine a winner in the event of a draw.
27. Any alterations of garments for the Grand Final or failure to appear will result in disqualification.
28. The Grand Final will be held on the Race Day and the winner will be announced on this day.
29. The Promoter reserves the right to refuse to allow the winner to take part in any or all aspects of the prize, if The Promoter determines, in its absolute discretion that the winner is not in the mental or physical condition necessary to be able to participate.
30. All images and video footage of entrants become the property of the Promoter and may be used for future promotions by the Promoter.
31. The Promoter collects applicants' personal information in order to conduct the promotion. If the information requested is not provided, the applicant may be refused participation in the promotion. By submitting an application, unless otherwise advised by the applicant, each applicant consents to the information they submit with their application being entered into a database and the Promoter may use this information in any media for future promotional, marketing and publicity purposes without any further reference or payment or other compensation to the applicant, including sending the applicant electronic messages. All personal details of the applicants will be stored at the office of the Promoter. A request to access, update or correct any information should be directed to that office. In addition, all applications become the property of the Promoter and it is a condition of applying that those applications may be used by the Promoter for their own promotional, marketing and publicity purposes without restriction.

The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for personal injury which is suffered or sustained, as a result of participating in this promotion or taking any prize, except for any liability which cannot be excluded by law.
33. The Promoter, on race day reserves the right to refuse entry to anyone deemed to be inappropriately attired, displaying abusive language, or displaying drunken or inappropriate behaviour.
34. The Promoter accepts no responsibility for any tax implications that may arise from the prize winnings. Independent financial advice should be sought.
35. The Promoter reserves the right to cancel, terminate, modify or suspend the promotion at any time.
