Terms & Conditions

1. Rules on how to enter form part of the terms and conditions of entry.
2. By submitting your entry form, or registering to participate in the Mornington BMW Fashions on the Field (Competition), you agree to abide by the competition terms and conditions.
3. Entrants must be strictly 18 years old or older.

5. Entrants must not be dressed by a fashion designer and failure to comply with this will result in disqualification.
6. Entrants must register and compete in the category that corresponds with their age and gender on the day of the event.
7. Headwear is mandatory for all entrants, male or female.
8. Heats and a Grand Final will take place on the race day. Entrants, as determined by the judges, will proceed from the heats to the Grand Final which will take place directly after the heats. A maximum number of entrants, as determined by the promoter, will be accepted in the competition and once this maximum is reached registration will be closed.
 15. Online, faxed or posted pre-registration forms will be accepted until 5pm, Monday, 13th February 2012.
 16. All pre-registered entrants must report to the registration desk on race day during the registration opening times to sign in and confirm their position in one of the heats. Failure to appear during registration opening times will result in their place not being held.
 17. Heats may take place any time from 1.00pm on race day.
 18. The Mornington BWM Fashions on the Field will take place on the Fashion Stage, located near the front lawn at Mornington Racecourse. The promoter reserves the right to change the location of the competition on the race day at its complete discretion.
 19. Preliminary judging or heats may be introduced at the discretion of the Promoter on Race Day if deemed necessary.
 20. The Promoter reserves the right to offer Wild Card entries at any stage throughout Race Day, in which case the entrant will immediately progress to a heat or the grand final (at the Promoter's discretion).
 21. All prizes are non-transferable, non-exchangeable and not redeemable for cash. The Promoter reserves the right to substitute an alternative prize at its complete discretion at any point during the Competition.
 22. The promoter shall select and appoint the judges.
 23. Contestants will be judged on race wear attire, style, seasonal attention innovation and how well their millinery complements their outfit. Overall personal presentation, deportment and accessories will be considered.
 24. The judge's decision is final.
 25. The Promoter will determine a winner in the event of a draw.
 26. Any alterations of garments for the Grand Final or failure to appear will result in disqualification.
 27. The Grand Final will be held on the Race Day and the winner will be announced on this day.
 28. The Promoter reserves the right to refuse to allow the winner to take part in any or all aspects of the prize, if The Promoter determines, in its absolute discretion that the winner is not in the mental or physical condition necessary to be able to participate.
 29. All images and video footage of entrants become the property of the Promoter and may be used for future promotions by the Promoter.
 30. The Promoter collects applicants' personal information in order to conduct the promotion. If the information requested is not provided, the applicant may be refused participation in the promotion. By submitting an application, unless otherwise advised by the applicant, each applicant consents to the information they submit with their application being entered into a database and the Promoter may use this information in any media for future promotional, marketing and publicity purposes without any further reference or payment or other compensation to the applicant, including sending the applicant electronic messages. All personal details of the applicants will be stored at the office of the Promoter. A request to access, update or correct any information should be directed to that office.
